An Overview of Accomplishments



SUPPORT LIVE AT HOME

- Care management services provided to 3,133 individuals.
 330 individuals received services through selfdirected services.
- 92 volunteers and professionals received CHOICES health insurance training.
- Assistance was provided to 6,803 callers.
- Education, either in person or through written materials, was provided to 175,000 individuals.

ASSISTANCE & SUPPORT FOR THOSE CARING FOR LOVED ONES

- 1,950 family caregivers were assisted with information about community resources and benefits, respite care, and training.
- 319 family caregivers attended a national conference sponsored by AOASCC.

SUPPORT FOR PROFESSIONALS

- 620 individuals were provided education regarding elder abuse and fraud through the annual conference TEARS™.
- Interagency Council on Aging of South Central Connecticut, convened by AOASCC, provided education and networking opportunities for professionals from 32 organizations.

OPPORTUNITIES FOR STAYING ACTIVE & HEALTHY

- Three Moving for Better Balance (Tai Chi) training series were held with 40 participants.
- 379 works of art by 153 artists were displayed at the annual Art of Aging Exhibition.
- 19 people were trained for the Live Well program.
 178 individuals participated in Live Well sessions, with 95 completing the program.
- 368 volunteers provided over 173,000 hours of service to older adults and children in the greater New Haven area.
