Every year, we assist thousands of older adults and people with disabilities, and their caregivers, with a range of services to help them remain at home and engaged in the community. This year, we celebrated 50 years of offering our critical support to our region. As we look to the future, the care we offer will remain essential for so many of our family members, neighbors, and friends. Thank you for your support of our organization. Because of you, we can continue our work supporting older adults, filling gaps in services, developing new strategies, strengthening the aging network, and thinking creatively about how we can help older adults and people with disabilities age in place.

Last year, we provided our expertise to 15,000 individuals. Here are the highlights:

Remaining at home is a primary goal for many older adults.

- 4,480 older adults and individuals with disabilities were able to remain at home through care management or self-directed services.
- Over 8,000 people received guidance about community resources and benefit programs to support their independence.
- 3,600 individuals received food from Meals on Wheels, grocery support, and nutrition information through benefit and community programs.

Caring for Loved Ones, Supporting Caregivers

- We guided 3,300 family caregivers with critical support and information about community resources and benefits, respite care, and specialized training.

Celebrating Older Adults and Staying Active & Healthy

- 243 works by 74 artists were displayed at our 10th Annual Art of Aging Exhibition, and nearly 200 volunteers served in the community through our programs.

Supporting our Aging Colleagues and the Aging Network

- We continue to lead the way on education about elder abuse and fraud in our region. Nearly 300 of our colleagues were provided elder abuse and fraud training through our annual TEARS™ conference.

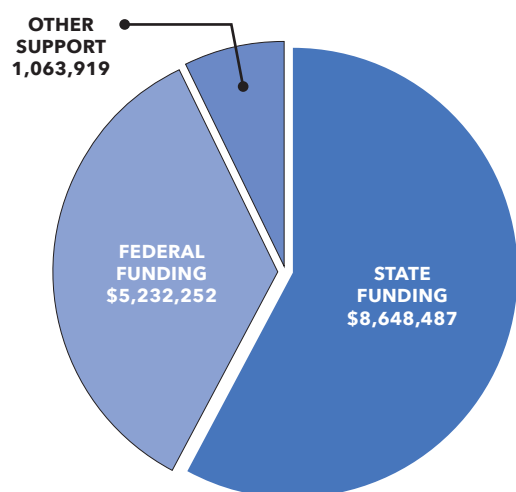
